MEMBERSHIP TERMS & CONDITIONS

ARTICLE 1: MEMBERSHIP APPLICATION AND MEMBERSHIP CARD

- a. Application to become a member is initiated by completing a registration form and returning it to B-Active. Membership begins upon receipt of payment of the membership fee. There is a one-time registration fee of US\$ 100,000 which includes US\$ 45,000 for a B-Active membership card. B-Active has the right to use the information provided on the registration form to contact or communicate with members.
- b. During the first visit to B-Active and on presentation of valid identification the new member will receive his/her B-Active membership card. Access to the B-Active facilities shall only be granted upon presentation of a valid membership card.
- c. The member is at all times responsible for the use of the membership card. The membership card is personal and non-transferable.
- d. Should the member no longer be in possession of their membership card due to loss, theft or any other reason, he/she can obtain a replacement at a fee of US\$ 45,000.
- e. An applicant re-joining B-Active within one year of a lapsed membership is not required to pay the registration fee.

ARTICLE 2: TERMS OF MEMBERSHIP AND PAYMENT

- a. The minimum age for membership is sixteen (16) years and above.
- b. Members are eligible to use the facility upon full payment of the membership fee for the respective period.
- c. Membership fees are non-refundable and membership is non-transferable. When not in use, membership cannot be suspended or frozen.
- d. A member can be refused access to B-Active facilities if his/her membership has expired
- e. B-Active reserves the right to change its rates. Members will be informed of a rate change at least 3 months before it takes effect. For current or existing memberships, rates changes will not be applied during the term of the membership contract.

ARTICLE 3: GUESTS

- a. Members may invite a guest at the specified daily guest rate.
- b. The guest must at all times be accompanied by the member
- c. Members shall be responsible for their guests' conduct and safety while using the facilities.

ARTICLE 4: TERMINATION OF MEMBERSHIP

- a. A member may terminate his/her membership by giving (at least) one month's written notice. However, no refund of membership fees will be made.
- b. Membership shall be terminated on the date the membership period paid for expires.
- c. B-Active reserves the right to terminate membership or deny a member access to the facilities, in case of serious or repeated breaches of these Terms & Conditions, the House Rules or other inappropriate behaviour at the discretion of the manager without refund of membership fee.

ARTICLE 5: WORKOUT TIMES AND OPENING HOURS

- a. B-Active reserves the right to change workout times, workout locations, programmes, classes, etc.
- b. Opening times are from 6.00am up to 9.00pm. B-Active reserves the right to change opening hours. In case of such changes, members will be notified at least 1 month in advance.
- c. If a member does not use his/her right to participate in unlimited training or in classes offered by B-Active, there will be no refund of fees.
- d. B-Active is legally entitled to be closed on official holidays but notification will be posted in advance of such closings.

ARTICLE 6: CLASSES

- a. Members are entitled to participate in all aerobics classes. Some fitness classes must be paid for by members. Such classes will be specified from time to time.
- b. Reservation for classes may be made only on the premises by obtaining a token in advance from the reception.
- c. B-Active reserves the right to cancel any or all classes. Notice of cancellation will be made via email and/or a notice posted in the premises.
- d. A timetable of classes shall be posted in the premises. B-Active reserves the right to, at any time, adjust the timetable of classes or make changes to the programme offered.

ARTICLE 7: HOUSE RULES

- a. Members are obliged to be aware of the B-Active House Rules and to comply with them. The House Rules will be clearly posted at the premises.
- b. Any member or member's guest found to be in breach of the House Rules will be asked to leave the premises and their membership (if applicable) may be terminated.
- c. The House Rules as well as the Terms & Conditions of membership are available from B-Active upon request.

ARTICLE 8: HEALTH AND HYGIENE

For your own safety, consult your doctor prior to the use of any facilities. Please:

- Do not use the above facilities if you have any contagious ailments, cuts or wounds.
- Do not shave in the steam room, sauna or shower.
- Do not use the facilities (gym, steam and sauna) while under the influence of alcohol, drugs, anticoagulants, antihistamines, beta blockers, narcotics or tranquilizers.
- Do not smoke in any of the facilities.
- Note that consumption or storage of food and alcohol in the gym is not allowed
- Do not take bottles, glasses, newspapers and magazines into the sauna and steam rooms

ARTICLE 9: DAMAGE AND LIABILITY

- a. The Owners, Management, their agents or servants shall not be held liable for personal injury or death of any member or his/her guests howsoever caused.
- b. The use of equipment, participation in a class or any other activity offered by B-Active is entirely at the members own risk.
- c. B-Active accepts no liability for loss, theft or damage of any member's or his/her guests' personal property.
